Public Hearing

Mayor Jake Ayers called the Public Hearing to order at 7:05pm to hear citizen comments on the proposed 2024/2025 budget. There were no citizen comments, and the Public Hearing was adjourned at 7:05pm.

Regular Meeting

Call to Order: Mayor Jake Ayers called the Regular Meeting to order at 7:06 pm. Present were Council Member Michael Taylor, Council Member Matthew Morgan, Council Member Mandy Neese, Council Member Mark Ayers, and Council Member Kandis Strickland. Also present were City Manager Lisa Kelly, Assistant City Manager Niles Ford, City Attorney Alex Dixon, Police Chief Jeff Sheppard, and City Clerk LeAnn Lehigh.

Council Member Morgan gave an invocation and Mayor Ayers led the Pledge of Allegiance.

CONSENT AGENDA

Motion: Council Member Taylor moved approve the Consent Agenda. The motion was seconded by Council Member Ayers.

OLD BUSINESS

1. 2nd Reading and Adoption - Ordinance - GMEBS Retirement Plan Update

Motion: Council Member Neese moved to adopt the ordinance amending the text of the GMEBS Retirement Plan Ordinance to comply with IRS tax regulations. The motion was seconded by Council Member Strickland.

Discussion: None Motion Carries 5-0

NEW BUSINESS

1. Demo of 301 Green Ave & 402 W. Main St. Bid Award

Motion: Council Member Neese moved to award the bid to Platinum Demo & Grading in the amount of \$10,200 for demolition of 301 Green Ave & 402 W. Main St. The motion was seconded by Council Member Ayers. Discussion: Both houses were in very poor shape due to fires. Both homes have gone through nuisance abatement. Motion Carries 5-0

2. Hogansville Municipal Court Parking Agreement - First Baptist Church

Motion: Council Member Strickland moved to approve the agreement with First Baptist Church, that would allow use of the parking lot at First Baptist Church for monthly municipal court. The motion was seconded by Council Member Ayers.

Discussion: None Motion Carries 5-0

3. 23-24 Budget Amendment - Community Development Director

Motion: Council Member Neese made a motion to approve the 2023/2024 budget amendment in the amount of \$2,880 to hire a new Community Development Director. The motion was seconded by Council Member Ayers. Discussion: City Manager is asking for the amendment in the amount of \$2,880 to cover payroll for the new Community Development Director for the month of June. The new Community Development Director position is budgeted in the 2024/2025 proposed budget that would begin July 1. The new Community Development Director will shadow Lynne Miller for six months until Lynne retires at the end of the year.

4. Joint Development Authority of Meriwether County & City of Hogansville – Amended and Restated Economic Development Agreement

Motion: Council Member Neese made a motion to approve the amended and restated economic development agreement for the Joint Development Authority of Meriwether County & City of Hogansville. The motion was seconded by Council Member Ayers.

Discussion: Mando is expanding their plant that would add 150 jobs to the surrounding areas. Since City of Hogansville is a member of the Joint Development Authority, they are being asked to sign the amended economic development agreement.
